#### **Improvements**

SQ-776	Removed Manager and RP Fields from Site, Department, and Document Type	The Manager and Responsible Person (RP) fields have been removed from Site, Department, and Document Type objects.
		These fields were not serving a functional purpose in this context. Their removal simplifies the interface and reduces confusion, ensuring that only the Metadata Admin user group retains the ability to edit these objects, in line with their intended use.
SQ-890	Updated Quiz Dashboard Interface  – Submit Button Removed, Reset Button Added	The "Submit" button previously displayed at the bottom of quizzes has been removed, as it was non-functional. A new "Reset Quiz" button has been added to allow users to clear their answers and start over if needed.
		This update improves the quiz-taking experience by removing a misleading element and introducing a useful option for resetting answers. It provides a clearer and more intuitive interface for users completing quizzes.
SQ-916	New Upper Caps Option for Month in Date Format	A new option has been added to support all capital letters for the month in the date format. In addition to the existing dd-MMM-yyyy format, the deployment tool now allows displaying dates as 01-JAN-2025.
		This enhancement addresses customer requests for greater formatting flexibility and supports consistency with external systems or documentation standards that require months in uppercase.
SQ-955	Retire Documents in "Awaits Update" Status Without Releasing	It is now possible to retire documents directly from the "Awaits Update" status, without requiring the document to be released first.

		This update streamlines the document lifecycle by allowing users to retire outdated or unneeded documents earlier in the process.
		It reduces unnecessary steps and supports more flexible document management.
		Note: For document types that require a change request, a change request is still required in order to retire the document. This behavior remains unchanged.
SQ-963	Option to Force Re-Training Before Training Record Expiry	A new option has been introduced to manually trigger re-training on a training record before it expires. From the "Learned and Valid" state, it is now possible to Activate Re-Training.
		This enhancement gives Training Managers and Quality Responsible Persons the ability to proactively manage training by requiring retraining when necessary—without waiting for the original record to expire.

SQ-928	Bug Fix for Product Item Getting Stuck in Ready for Approval state	An issue has been resolved where a product item added as a controlled item in a change request could not be re-added after removal. This occurred because the product remained in the "Ready for Approval" state, preventing it from being linked again.
		With this fix, product items can now be properly removed and re-added as controlled items in change requests, ensuring smoother editing and accurate relation management throughout the change process.
SQ-950	Hidden Discontinued "Quiz Learning Rule" Class	The "Quiz Learning Rule" class option, which had been discontinued, was still visible for selection despite no longer being supported. This option has now been properly hidden from the interface.
		This fix prevents confusion by ensuring that deprecated options like "Quiz Learning Rule" are no longer visible to users. It aligns the interface with current functionality and maintains a cleaner, more

SQ-951	Corrected Handling of Effective Date Formatted on Templates	Previously, when creating a document from a template, the Effective Date formatted value from the template was sometimes copied over to the document.
		This issue has now been resolved. Documents created from a template will no longer copy the Effective Date formatted value from the template. Instead, each document will use its own Effective Date formatted, ensuring consistency and preventing unexpected data loss.
SQ-957	"Continue Review" Option Restored for Quizzes	An issue has been resolved where the "Continue Review" option was not available after modifying the reviewers of a quiz. This prevented users from proceeding with the review process once reviewer changes were made.  With this fix, users can now properly see and use the "Continue Review" option after updating quiz reviewers, ensuring a smooth and uninterrupted
SQ-986	Approver's Names Now Displayed on Effective Copy	review workflow.  A bug has been fixed where the approver's name was not appearing in the header of the effective copy of a document, despite using the correct code: "Approver(s) – Completed".  The approver's name is now correctly displayed on the effective copy, ensuring proper visibility of approval information and improving compliance and document traceability.
SQ-949	Corrected Filtering for Grouping Levels in View	An issue has been resolved where the filtering was incorrect in the "2. Main View > 1. All documents > 1.5 By State" view.  With this fix, the grouping and filtering are now properly aligned, ensuring more accurate and reliable document views. Users will now be able to efficiently sort and filter documents by state as intended.
