SQ-1026	Responsible person reverting to default value on CR effectiveness assessment	Fixed an issue where updating the Responsible Person during a Change Request Effectiveness Assessment would revert to the original value after clicking Schedule.
SQ-1036	Periodic Task Stuck in "On-hold"	<p>Resolved an issue where Periodic Tasks in the On-hold state could not be updated or routed further because the Responsible Person had no available state transition options.</p> <p>Tasks can now be moved out of On-hold by the Responsible Person.</p>
SQ-1039	Training Views Not Grouping Correctly	Fixed an issue where two training views were not correctly grouped by Training Group, causing incorrect filtering and display.

SQ-1052	Product State Incorrect When Removed From Change Request	<p>Fixed an issue where an Effective product incorrectly moved to Draft when it was removed from the scope of a Change Request.</p> <p>The product now correctly returns to the Effective state when excluded from the CR.</p>
SQ-1053	Duplicate Background State Transitions	<p>Fixed an issue where some transitions could trigger more than once (e.g., routing a document for a major version update twice).</p> <p>The system now ensures each background transition is executed only once, preventing duplicate released versions or unintended version increments.</p>
SQ-1060	Template Working Copy Not Converting to PDF	<p>We've seen recurring issues where template working copies fail to convert to PDF, even after previous fixes.</p> <p>To ensure reliability going forward, we are implementing a stable solution that will automatically detect when a released template has not been converted and re-trigger the PDF conversion after 10 minutes. This will prevent templates from getting stuck without converting to PDF.</p>
